Bylaws

During our last couple Focuses, I shared the Draft of the proposed Bylaws. Attached (at the end of the FOCUS) you will find an updated version of the draft. The only changes that have occurred are changing the names of the Executive Committee to Executive Council and the Governing Board to Governing Council. The Executive Council recommended this change to align with the language utilized by the American Counseling Association for similar groups of individuals.

I know some of you might be wondering why our Bylaws have been talked about so much lately. In 2017, as an association, we voted on some language updates that passed at our Annual Conference. Since we are a branch of the American Counseling Association (ACA), we must have our Bylaws reviewed by ACA every ten years and when we have changed the Bylaws. The updated Bylaws were sent to ACA and reviewed in late 2019. ACA has many areas that must be in place within our Bylaws per their Bylaws, Policies, and Procedures. There are nine compliance requirements; we only met three areas in the review.

Additionally, ten areas of standard articles need to be in place; we only had four sections present with all the outlined requirements. In other words, we were missing the mark in the ACA requirements for our Bylaws. As a branch of ACA, we must meet these requirements so we can continue to have the support of ACA and align ourselves with the larger association.

All of the recommendations from ACA were ways to protect our association, outline how our association runs, and, most of all, set the association up for continued growth and survival. Also, as an Executive Council and Governing Council, we want to increase transparency to our members through the Bylaws. All of this to say, we need these updates.

In coming up with the current draft, I reviewed the Bylaws of our southern neighbor, the South Dakota Counseling Association, since we have so many similarities in the communities that we serve and the rural feel of our areas. Additionally, South Dakota has been highly supportive of us as an association. Through the recommendations from ACA, the review of SDCA's Bylaws, and ACA's Bylaws, we ended up with the current draft you see here.

Again, as members, I ask you to review the attached draft and reach out with questions, concerns, thoughts, and anything so that we have the best Bylaws for our association's future. Please reach out to me at bmeidinger88@gmail.com. We will be voting on these bylaws during the Annual Conference on Monday, February 13th, 2023.

Finally, I will be looking for nominations for the President-Elect-Elect Election that will be taking place in February 2023 at the Annual Conference. If you have previously served for a year on the Governing Council, I challenge you to think about how you could serve the association as a part of the Executive Council. As I am in my last year on the Executive Council, I am so excited to see the fantastic things that Amy, Chasity, and Danielle have planned for the future. Government Affairs Update

The American Counseling Association (<u>ACA</u>), American Mental Health Counselors Association (<u>AMHCA</u>), and the National Board for Certified Counselors (<u>NBCC</u>) are working in collaboration with the Medicare Mental Health Workforce Coalition to urge your organization and your members to <u>Contact Congress Today</u> in support of passing the:

MENTAL HEALTH ACCESS IMPROVEMENT ACT (S.828/H.R. 432)

Passing the Mental Health Access Improvement Act would provide:

- 225,000 Mental Health Counselors and Marriage and Family Therapists the *option to enroll* as Medicare providers.
- Create a new stream of income for eligible Professional Counselors.
- Increase access to care for our nation's older Americans, the disabled population, and increase veteran's provider choice for mental health care.

Where Are We Now:

- The U.S. House version of the bill passed out of the House Ways & Means Committee.
 - o The next step is for the full House of Representatives to Vote on this bill.
- The U.S. Senate version of the bill was included in the Senate Finance Committee's draft package on improving the mental health workforce.
 - o The Senate may vote on a final package prior to the close of the 2022 Congressional Session.,

YOU CAN SUPPORT THE PROFESSION:

Over the past decade we, along with partner organizations, have advocated for the successful passage of this bill. The bill has passed in both the House and Senate previously, but it has never happened at the same time. This is the **first** congressional session where passage of this bill in both chambers of Congress is realistic.

For bill passage to happen, we need you to advocate for this bill. There are two major steps you <u>must</u> take:

1. **CONTACT YOUR SENATE HEALTH STAFFER:** Below you will find a list of Senate Legislative Assistants. Please locate your Senator, and draft a brief e-mail to the staff contact informing them:

The benefit that constituents in the state will have once the Mental Health Access Improvement Act passes.

- Clearly describe the issues you and your clients face because of the outdated Medicare Policy. Please see the examples below, to help you draft your e-mail:
 - o Provide a copy of the Medicare Mental Health Workforce Coalition Congressional One Pager
 - o Note that outdated language in current Medicare coverage legislation has resulted in many individuals who rely on Medicare experiencing a variety of challenges to getting the care they need, including:
 - Limited access to more affordable treatment options
 - Lack of continuity of care when individuals in therapy either age into Medicare or become Medicare-eligible due to permanent disability
 - Lack of access to 40% of behavioral health professionals with a master's degree
 - Barriers to better integration of physical and mental health care
 - Lack of access to coordinated benefits for dual eligible beneficiaries and veterans with Medicare because LPC/MHCs and LMFTs are not recognized as Medicare providers
 - Likelihood of foregoing or discontinuing therapy altogether for individuals living in rural areas with few or no available Medicare providers

The Mental Health Access Improvement Act (S. 828/H.R.432) would close the gap in federal law that prevents MHCs/LPCs and LMFTs from being recognized as Medicare providers. The legislation would give Medicare beneficiaries immediate access to over more than 225,000 additional licensed mental health professionals and help close the widening treatment gap.

Ethics Topic: Social Media: 10 tips for Professional Counselors

Have you ever wondered what our Code of Ethics states about use of social media in and outside the professional setting? Here are 10 tips from ACA. More information may be found at www.counseling.org

Social Media: 10 Tips for Professional Counselors

American Counseling Association: Counselors Advocate

- 1. Make sure your professional social media accounts are separate from your personal accounts. It's a good idea to keep your personal accounts private (ACA Code of Ethics H.6.a.).
- 2. Learn everything you can about social media. Be sure you understand the various platforms' purposes and operations, including their privacy controls (H.1.a.).
 - 3. Don't share confidential information on social media, even in closed/private settings. Non-professionals may have access to that information (H.6.d.).
 - 4. Don't diagnose individuals in social media posts, even if they are public figures.
- 5. If you wouldn't say it in real life, don't post it online. Your statements have weight (C.6.c.). Keep in mind that values and beliefs shared online can make their way to clients, employers, counseling education programs, membership organizations, and other professionals.
 - 6. Be accurate and appropriate in the portrayal of your education, licensure, accreditation, expertise, and memberships. The ACA advertising/promotion ethical standards apply to social media, too (C.3.).
- 7. Don't check out a client's social media profile without permission, even if it is public (H.6.c.). Keep in mind that personal virtual relationships with current clients are prohibited (A.5.e.).
 - 8. Counselors and counseling-related organizations must develop a social media policy. Information about this policy must be included in informed consent documents for clients and should be posted on professional social media pages and websites (A.2.b.).
- 9. Social media policies should cover the risks, especially to confidentiality, and the benefits of interacting with counselors on social media, as well as the expectations clients should have when interacting with a counselor's professional social media account (H.6.b.).
- 10. Become familiar with—and follow—all of the social media guidelines listed in the 2014 ACA Code of Ethics

North Dakota Counseling Association Bylaws

Article 1 - Name

The name of the Association shall be North Dakota Counseling Association. The Association is a branch of the American Counseling Association that shall comply with the ACA Article of Incorporation and Bylaws.

Article 2 - Mission

North Dakota Counseling Association will provide quality professional development opportunities, facilitate networking, advocate for the counseling profession, and promote leadership activities and encourage active involvement in the organization.

Article 3 - Members

Section 1. Membership in the State Branch shall be of one type – individual.

Section 2. Individual Membership shall be Professional, Affiliate, Student, or Retired

- a. Professional: Membership is available to any person that has earned a master's degree or higher in Professional Counseling or related profession, and who is actively engaged in counseling practice and/or education. All such persons shall become a Professional Member of the Association upon payment of dues and will end the last day of the calendar year. Professional Members shall be able to attend meetings and hold office in the Association.
- b. Affiliate: Membership is available to individuals who interests, activities, and/or professional backgrounds are consistent with those of the Association, but do not hold or in the process of earning a graduate level degree in the field of Professional Counseling or related profession. All such persons shall become Affiliate Members of the Association upon payment of dues and will end the last day of the calendar year. Affiliate Members may not hold office in the Association.
- c. Student: Membership is available to any person who is currently enrolled in an approved program in Professional Counseling. All such persons shall become a Student Member of the Association, with the endorsement of the student's major advisor, upon the payment of dues, and will end the last day of the calendar year. Student Members shall be able to attend meetings and hold office in the Association.
- d. Retired: Membership is available to any person who is retired from the Counseling Program. All such persons shall become Retired Members of the Association upon the payment of dues and will end the last day of the calendar year. Retired Members shall be able to attend meetings and hold office in the Association.

Section 3. Dues

 Dues for members of the Association shall be recommend by the Executive Council and established by the Governing Council.

Section 4. Severance of Membership

a. A member may be dropped from membership for any conduct that tends to injure the Association or to affect adversely, its reputation, or that is contrary to or destructive of its mission according to the ACA By laws and the ACA Code of Ethics. Any member charged with engaging in any such conduct shall be given notice of the precise nature of the charge, shall be given the opportunity to present evidence, through witnesses or otherwise, shall be given the opportunity to confront witnesses and shall have the right to appeal to and have a hearing, limited to one hour in duration, before the Governing Council, whose decision shall be final.

b. A member may be dropped from membership for the nonpayment of dues.

Article 4 – Officers of the Association

Section 1. Officers and Terms of Office

- a. The officers of the Association shall be the President, the President-Elect, the President-Elect, the immediate Past President, and the Executive Director.
- b. All officers of the Association, except the Executive Director, shall be elected at large from among the individual members of the Association and shall serve for one-year terms and until their successors are elected.
- c. The Executive Director shall be appointed by the Governing Council and shall serve at its pleasure.
- d. The President-Elect shall automatically become President of the Association one year after the commencement of the term of office as President-Elect, or upon the death or resignation of the President.
- e. The President-Elect shall automatically become President-Elect of the Association one year after the commencement of the term of office as President-Elect-Elect, or upon the death or resignation of the President or President-Elect. If a vacancy occurs within the President-Elect-Elect position, the position will be appointed by the President and approved by the Executive Council.
- f. An elected officer shall not be eligible to serve a second consecutive term, provided, however, that a President-Elect in succeeding to the office of the President by reason of death or resignation of the president shall serve a full one-year term as President in addition to serving the unexplored term of the resigned or deceased President.
- g. The term of office of any elected office of the Association shall begin on July 1 and the office selected shall serve for a period of one year and until a successor takes office.
- h. The elected officers for the Association shall be current members in good standing of the American Counseling Association and the Association.

Section 2. Duties of Officers

- a. The President shall be the chief elected office of the Association. The President shall be Chairperson of and preside at all meetings of the Association. The President shall serve as an ex-officio member on all committees. The President shall appoint special committees when deemed necessary. The President shall represent the Association at regional and national meetings or shall designate an Association member to represent the Association. The President shall delegate tasks to the Executive Director of the Association as directed by the Governing Council. The President shall perform the duties customary to that office and such additional duties as directed by the Governing Council.
- b. The President-Elect shall perform the duties of the President in the absence or incapacity of the President as determined by the Governing Council.
- c. The President-Elect-Elect shall perform the duties of the President in the absence or incapacity of the President and President-Elect as determined by the Governing Council.
- d. The Executive Director shall serve as the executive officer of the Association. The Executive Director shall serve as the Treasurer and Secretary of the Association. The Executive Director shall perform the duties customary to the offices of Treasurer and Secretary and such duties as may be directed by the Governing Council. The Executive Director shall be responsible to transact the Association's day-to-day business activities and operations. The Executive Director shall be an ex-officio member of the Executive Council and Governing Council.

Section 3. Nominations and Elections of Officers

a. The Immediate Past-President shall serve as the Nominations and Election Committee Chair. The Nominations and Election Committee shall conduct the election of officers, according to the Policies and Procedures Manual, by ballot provided to the voting members of the Association via mail and internet.

Section 4. Compensation and Expenses of Officers

- a. None of the elected officers of the Association shall receive any compensation for services as such to the Association. The necessary expenses of the elected and appointed officers of the Association may be paid from the funds of the Association under the policies of the Governing Council established for such payments.
- b. The Executive Director shall be paid such compensation from the funds of the Association as may be fixed in the annual budget by the Governing Council.

Section 5. Removal of Officers

a. Any elected Officer may be removed from office, with or without cause, upon a vote of a majority of the Governing Council members then in office to remove them from the Officer position, whenever the Governing Council members' judgment the best interest of the Association would be served thereby, provided that all the Governing Council members have at least ten days' notice of the proposed removal and the Officer at issue has an opportunity personally to address the Governing Council prior to the removal vote. Any officer appointed by the President may be removed with or without cause by the President

Article 5 - Meetings and Actions of the Membership

Section 1. Calling of Membership Meetings

a. The Association shall hold membership meetings at a time and place fixed by the Governing Council, which shall give written notice thereof to the membership not less than three months prior to the time so fixed.

Section 2. Manner of Acting and Decision-Making

- a. A majority of the votes cast on a matter where a quorum is present shall be necessary for the adoption thereof unless a greater proportion is required by law or these Bylaws. If so arranged by the President or Executive Director with respect to any matters that may be voted on by voting members, including the election of the officers, such members may vote by postal mail or electronic ballot.
- b. If so arranged by the President or Executive Director, voting members may participate in a meeting where members are voting by means of a conference telephone or other telecommunication device that allows all persons participating in the meeting to hear each other and to have their views heard. Such participation in a meeting shall be deemed presence in person at such meeting.
- c. If and when the law is amended to so permit, this Bylaw shall empower the voting members to conduct and participate in meetings by electronic communications in which words are transmitted to all participants.
- d. Those voting members who have at least one-tenth of the votes entitled to be cast represented in person or by proxy shall constitute a quorum.

Article 6 - Governing Council

Section 1. Composition

a. The Governing Council of the Association shall consist of:

- The officers of the Association.
- ii. The representatives of the Association Divisions according to the Policies and Procedures Manual.
- iii. The chairs of committees.
- iv. Each member shall have one vote except the Executive Director and any ex-officio members who shall serve without vote.

Section 2. Powers and Functions of Governing Council

- a. The Governing Council of the Association shall:
 - i. Establish policies to govern the affairs of the Association.
 - ii. Formulate operational policies appropriate for executive action and direct the execution thereof.
 - iii. Grant, deny, and revoke Division charters.
 - iv. Develop, promote, and execute plans that have the approval of the Association for promoting cooperation and affiliation with the other organizations having interests similar to those of the Association while remaining autonomous.
 - v. Act upon the reports of the Executive Council, Standing Committees, and such special committees as are responsible to it.
 - vi. Establish the duties of and hire an Executive Director.
 - vii. Adopt and amend By-Laws.
 - viii. Act upon the annual budget proposed by the President.
 - ix. Approve appointments of the chairpersons of the standing committees as submitted by the President.
 - x. Exercise such other powers and functions as may be necessary or desirable in the best interest of the Association, not in conflict with the Bylaws.

Section 3. Meetings of the Governing Council

- a. The Council of Directors shall meet a minimum of two times annually, once at the Association Conference and once as arranged by the President. Meetings may also be called by a majority of the Governing Council.
- b. In order to conduct an official meeting the Governing Council must have a quorum present consisting of a majority of the voting members of the Governing Council. Votes upon changes to the Bylaws, approval of the annual budget, and dissolution of a Division must have a quorum present of at least two-thirds of the voting members.
- c. Alternates for Division representatives must identify themselves as official designees at the time the roll call is taken for Council Members present. No member may represent more than one Division. Representatives must be members in good standing of the Division which they represent. Officers of the Association may not serve as official designees of a Division.

Section 4. Executive Council

a. The Executive Council of the Governing Council shall consist of the President, Immediate Past President, President-Elect, President-Elect-Elect, and Executive Director. The Executive Director shall serve without vote. The Executive Council shall act for the Governing Council during the interim between meetings of the Governing Council but within the limits of such written policies as may be established by the Governing Council. Its duties shall include:

- i. The Executive Council shall act for the Governing Council within policies as may be established by the Governing Council. The Executive Council shall function primarily to address those issues which are necessary for the efficient operations of the Association where the time requirements necessitate immediate action. All actions and activities of the Executive Council shall be communicated to the Governing Council through minutes which are sent electronically within ten working days of an Executive Council meeting. The actions Governing Council at the next meeting.
- ii. The Executive Council shall be responsible for conducting the evaluation of the Executive Director on an annual basis, for negotiating renewal of their contract, and for determining the recommended salary of the Executive Director which will be included in the annual budget of the Association.

Article 7 – Committees

Section 1. Committees.

- a. The standing committees of the Association shall be the Ethics Committee, Government Affairs Committee, Scholarship Committee, and Awards Committee.
- b. The Policies and Procedures Manual will include operational guidelines, oversight, purpose, lifespan, and procedures for review for all committees (standing and special).

Section 2: Committee Chairs and Members

- a. Committee Chairs are appointed by the President with approval by the Governing Council. Committee members are appointed by the committee chair with approval by the President. Section 3. Reports.
 - a. Each committee shall make an annual report of its activities and status to the Governing Council at the end of each fiscal year.

Article 8 - Parliamentary Authority

The current edition of Robert's Rules of Order, Newly Revised, (edited by Henry M. Robert III and William J. Evans and published by Perseus-HarperCollins) shall govern the proceedings of all bodies of the Association except where otherwise specified by these Bylaws.

Article 9 - Bylaws

Section 1. Amending the Bylaws.

- a. These Bylaws may be changed or amended by either of the following methods:
 - i. Proposed amendments to the Bylaws may be presented to the Governing Council, by the Executive Council, the executive body of an Association Division, or by an individual member, provided that in the case of an individual member the proposed amendment must be submitted in writing to the Executive Director at least 60 days prior to a meeting of the Governing Council. The Executive Director shall transmit to the Governing Council for its consideration all such proposed Bylaws amendments, at least 30 days prior to the Council meeting.
 - ii. Proposed Bylaws amendments may be originated at a meeting of the Governing Council. Such amendments shall be submitted in writing not less than 45 days

following its origination by the Governing Council for a vote by electronic ballot to the Governing Council or at the next scheduled Council Meeting.

b. All amendments to the Bylaws are subject to the approval/acceptance of the American Counseling Association Governing Council.

Section 2. Procedures

- a. To vote upon amendments to the Bylaws, the meeting must have a quorum present of at least two thirds of the voting members of the Governing Council. A majority vote is required to adopt any proposed amendment.
- b. Any proposed amendment may be referred by the Governing Council to the general membership by referendum procedure.

Section 3. Policies and Procedures

a. Supplementary policies and implementation guidelines for these Bylaws are found in the Policies and Procedures Manual that will be kept current by the Executive Director.

Article 10 – Statement of Indemnification

Section 1. The Association will indemnify the officers and Governing Council members to the extent permitted by state law.
